## **AGREEMENT FOR ASSIGNMENT OF CLAIMS**

This Agreement for Assignment of Claims (“**Agreement**”) is entered into as of the date entered on Page 3 of this Agreement (the “**Effective Date**”), by and between Amazon Content Services LLC, or its applicable affiliate, (“**Amazon**”), and the undersigned Rights Holder, as defined by the *Bartz et al. v. Anthropic PBC* Settlement Agreement (“**Settlement Agreement**”) Clause 1.7 defining members of the Class, on Page 3 of this Agreement (“**Rights Holder**”). Amazon and Rights Holder are each referred to as a “**Party**” and collectively as “**Parties**” herein.

### **RECITALS**

- A. WHEREAS, Amazon as publisher and Rights Holder entered into an agreement for the publication and reproduction of the works listed in Appendix A to this Agreement (“**Work**” or “**Works**”).
- B. WHEREAS, that Work or those Works were downloaded by Anthropic PBC (“**Anthropic**”) from unauthorized sources for purposes of training large language models (LLMs).
- C. WHEREAS, Andrea Bartz, Charles Graeber, and Kirk Wallace Johnson (“**Plaintiffs**”) filed a class action lawsuit against Anthropic alleging that the acts of downloading copyrighted publications infringed on the copyrights in the classes’ publications; the Work or Works are among the publications in the class; and the Plaintiffs have entered into a settlement for which class members can choose to opt in or opt out, *see Bartz et al. v. Anthropic PBC*, No. 3:24-cv05417-WHA (N.D. Cal.) (“**Anthropic Settlement**”).
- D. WHEREAS, Rights Holder has requested that Amazon enter into this Agreement and Amazon has agreed to do so.
- E. WHEREAS, through this Agreement, Amazon desires to assign to Right Holder its interests in the claims resolved by the Anthropic Settlement as it relates to the Work or Works.

### **AGREEMENT**

NOW, THEREFORE, in consideration of the mutual covenants contained in this Agreement, including, without limitation, the existing and ongoing business relationship between Amazon and Rights Holder, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

The foregoing recitals are true and correct.

1. Amazon hereby irrevocably conveys, assigns and transfers to Rights Holder all of

Amazon's claim in the Anthropic Settlement (the "**Action**") including, without limitation, any proceeds resulting from the Action which Amazon has or may have against Anthropic under the copyright laws of the United States or the common or statutory law of any state arising out of or relating to the Work or Works at any time in the past through and including the Effective Date ("**Assigned Claims**").

2. Assigned Claims are limited to the identified Work or Works and claims asserted in the following action: *Bartz et al. v. Anthropic PBC*, No. 3:24-cv05417-WHA (N.D. Cal.).
3. As of the Effective Date, Rights Holder shall become the owner of the Assigned Claims, and shall have full authority to pursue, settle, waive or dismiss, in its sole discretion, any claims, in whole or in part, that it may prosecute or pursue on the basis of this Agreement, except as limited by Clause 4 below, in *Bartz et al. v. Anthropic PBC*, No. 3:24-cv05417-WHA (N.D. Cal.).
4. In the event that two or more Rights Holders present an Agreement for the same Work or Works, the Rights Holders agree that the Special Master assigned to *Bartz et al. v. Anthropic PBC*, No. 3:24-cv05417-WHA (N.D. Cal.) shall adjudicate any disputes related to the Claim or Claims, as described in the Settlement Agreement Clause 5.1(h). Rights Holder agrees that it will not bring claims against Amazon in connection with or arising out of this assignment.
5. This Agreement constitutes the entire agreement between the Parties regarding the subject matter hereof and may not be modified, except by an instrument in writing signed by all Parties or their duly authorized representatives. Nothing in this Agreement, express or implied, is intended to confer on any party, other than the Parties to this Agreement and their respective permitted assigns, any rights or remedies under or by reason of this Agreement, and no person or entity of any kind whatsoever who is not a party to this Agreement may rely on the terms except as otherwise set forth in this Agreement. This Agreement is binding on, inures to the benefit of, and is enforceable by, the Parties and their successors, executors, heirs, representatives, administrators and permitted assigns.
6. No ownership interest in the Works or copyrights in the Works is being assigned or conveyed through this Agreement.

7. This Agreement will be construed and enforced in accordance with, and the rights of the Parties will be governed by, the laws of the State of Washington, excluding choice-of-law principles of the law of such State that would permit the application of the laws of a jurisdiction other than such State.
